QUESTION OF: Human rights of Lesbian, Gay, Bisexual and Transexual

<u>Congratulating</u> all Member States who contributed to make safe and indiscriminate LGBT people,

<u>Celebrating</u> all 94 Member States who have signed a General Assembly Declaration of LGBT rights,

Observing that many Members of the UN did not cope with the question of Human Rights of LGBT,

<u>Reaffirming</u> the ideal of equality and mutual respect expressed in the 2nd Article of the Human Rights Declaration,

Reminding that sexual orientation is a fundamental part of every individual,

<u>Noting</u> that in many states LGBT people are being discriminated and ill-defined and that are present curative treatments supposed to change sexual orientation,

Deeply regretting any of physical or psychological abuse on LGBT people,

<u>Confident</u> in the cooperation of the International Labour Organization (ILO), which is a tripartite UN agency that brings together governments, employers and workers of its 183 member states in common action to promote decent work throughout the world,

<u>Deeply disturbed</u> by the fact that LGBT people are discriminated from police forces, which should protect them,

<u>Reaffirming</u> the importance of the introduction of laws with the purpose of protect children from discrimination and abuses,

1) Asks all Member States to create campaign of sensibilization especially among youth population about LGBT people with the propose of expunge any type of discrimination;

- 2) Strongly urges all Member States to guarantee freedom of press;
- 3) Suggests the creation of the First Organization for Rights of Gay Extended in Totality to Transgender and All Bisexual and Lesbian Entities (UNFORGETTABLE) with the following features and purposes:
 - a. open to all Member States that respect all the other points of this resolution,
 - b. offer some services for LGBT people including:
 - i. psychological consultations or help from experts,
 - ii. open social groups that have same problems with them and to find a solution together,
 - c. propose a world day for LGBT in which Member States of the UNFORGETTABLE could adhere;
- 4) Requests International Labour Organization to encourage Member States to:
 - a. take the appropriate steps to avoid all discrimination forms in engagement for LGBT people,
 - b. acquire adequate parameters of merit for recruitment regardless of sexual orientation;
- 5) *Hopes* all Member States should provide that the police forces will protect all LGBT people;
- 6) Asks all Member States to cooperate with World Health Organization (WHO) to stop every kind of curative treatment supposed to change sexual orientation;
- 7) *Invites* all Member States to punish with adequate measures who inflict psychological or physical damage to all LGBT people;
- 8) *Suggests* to the Member States to take action in order to develop and impose sanctions to states that do not respect the 2nd Article of Human Rights declaration;
- 9) *Proposes* the Security Council to consider the possibility to engage its peacekeeping observers and experts in order to control the respect of Human Rights;
- 10) *Expresses its appreciation* for all the Member States who approves the transcription of civil unions occurred abroad or are going to introduce them;

- 11) *Encourages* all Member States, when is possible, to introduce for LGBT couples the possibility to adopt children in order to:
 - a. save them from situation of poverty,
 - b. provide them a safe place,
 - c. ensure them education,
- 12) Expresses its hope for future sessions to remain actively seized on this matter.
